RE: Posts on X.com by Josh Tyler

Dear Mr. Aldrich,

We hereby acknowledge receipt of your letter dated December 3, 2024, in response to our cease-and-desist letter addressed to your client, Mr. Josh Tyler (the "C&D Letter").

While we are familiar with the relevant law, we disagree with your conclusions and reiterate and reassert our position stated in our C&D Letter. Your client's false and misleading statements, taken as a whole, demonstrate a targeted and unsubstantiated campaign of harassment intended to tarnish Valnet Inc.'s ("Valnet") reputation by creating a false narrative that Valnet has an unfair advantage over independent publishers or that Google somehow intentionally favors Valnet. Such accusations are conspiratorial, false and defamatory.

Further, your client's numerous articles and social media posts concerning this matter since our C&D Letter (see Exhibit A for a non-exhaustive list) clearly demonstrate that your client does not have any intention to resolve this matter in good faith and is instead doubling down on his false narrative. In fact, your client's continued statements on this matter have served to further defame Valnet as evidenced by a response by another user to one of your client's social media posts following our C&D Letter, in which the user falsely suggests that Valnet pays Google to obtain favors (see Exhibit B). Clearly, your client's targeted campaign is defaming Valnet and damaging its reputation.

In view of the foregoing, Valnet reiterates its demands that Mr. Tyler must:

- a) Immediately cease and desist from making further false and defamatory accusations with respect to Valnet;
- b) Immediately take the necessary steps to remove the posts regarding Valnet from X.com and any other media platforms where they may have been published; and
- c) Immediately withdraw all unfounded and defamatory statements and allegations made, re-posted, or relayed, and confirm to the undersigned once this has been done.

Valuet will continue to monitor your client's articles, social media posts and other public activities, and will not hesitate to take legal action as it deems necessary to protect its rights and interests.





The present letter is sent without prejudice to Valnet's rights and remedies, and Valnet specifically reserves the right to revise the damages sought, including by claiming extra-judicial fees and legal costs incurred as a result of any potential litigation that it is being forced to institute due to your unlawful actions.






EXHIBIT A Josh Tyler Posts






















































EXHIBIT B Third-Party Post
